1. The **Provincial Government of Leyte**, through the DOH-HFEP Fund for Year 2013, intends to undertake the procurement of the following:

2017-021-10-2	Supply, delivery, installation and commissioning of On-Site Autoclave Medical Waste Sterilization Facility in Ormoc, Baybay, Burauen and Palompon District Hospitals in Leyte	30,000,000.00

2. The Provincial Government of Leyte, through its Bids and Awards Committee, now invites bids for the above-mentioned goods. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Delivery of the goods is required within **120 calendar days** from receipt of the Notice to Proceed. Bidders should have completed a contract similar to the project to be bid with a value equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary 'pass/fail' criterion as specified in the 2016 Revised Implementing Rules Regulations (IRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act".
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
5. Interested bidders may obtain further information from the Provincial Government of Leyte and inspect the Bidding Documents at the address given below during office hours, from Monday to Friday.
6. A complete set of Bidding Documents may be purchased by interested Bidders beginning **February 27, 2017** from the address below and upon payment of a non-refundable fee for the bidding documents in the amount of P 25,000.00 only:

7. The Provincial Government of Leyte will hold a Pre-Bid Conference at **2:00 PM** on **March 7, 2017** at the PPDO Conference Room, Provincial Capitol, Tacloban City, which shall be open only to all interested parties who have purchased the Bidding Documents.
8. Bids must be delivered on or before **10:00 AM** on **March 22, 2017** at the PPDO Conference Room, Provincial Capitol, Tacloban City. All bids must be accompanied by a bid security in any of the acceptable forms and their corresponding amounts stated in ITB Clause 18. Late bids shall not be accepted.
9. Bid opening shall immediately follow at **10:30 AM** on **March 22, 2017** at the same venue. Bids will be opened in the presence of the Bidders' representatives who may choose to attend.
10. The Provincial Government of Leyte reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
