1. The **Provincial Government of Leyte**, through its various Local Funds, intends to undertake the procurement of the following:

2. The Provincial Government of Leyte, through its Bids and Awards Committee, now invites bids for the above-mentioned goods. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidders should have completed a contract similar to the project to be bid with a value equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary 'pass/fail' criterion as specified in the 2016 Revised Implementing Rules Regulations (IRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act".
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
5. Interested bidders may obtain further information from the Provincial Government of Leyte and inspect the Bidding Documents at the address given below during office hours, from Monday to Friday.
6. A complete set of Bidding Documents may be purchased by interested Bidders beginning **April 10, 2017** from the address below and upon payment of a non-refundable fee for the bidding documents as follows:

7. The Provincial Government of Leyte will hold a Pre-Bid Conference at **2:00 PM** on **April 17, 2017** at the PPDO Conference Room, Provincial Capitol, Tacloban City, which shall be open only to all interested parties who have purchased the Bidding Documents.
8. Bids must be delivered on or before **10:00 AM** on **May 3, 2017** at the PPDO Conference Room, Provincial Capitol, Tacloban City. All bids must be accompanied by a bid security in any of the acceptable forms and their corresponding amounts stated in ITB Clause 18. Late bids shall not be accepted.
9. Bid opening shall immediately follow at **10:30 AM** on **May 3, 2017** at the same venue. Bids will be opened in the presence of the Bidders' representatives who may choose to attend.
10. The Provincial Government of Leyte reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
