1. The **Provincial Government of Leyte**, through its 20% Development Fund for CY 2015 & 2017, Special Education Fund for CY 2017 and the DILG-BUB Fund, intends to undertake and implement the following civil works projects:

2. The Provincial Government of Leyte, through its Bids and Awards Committee, now invites bids for the above-mentioned civil works. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidders must have completed a contract similar to the project to be bid with a value equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary 'pass/fail' criterion as specified in the 2016 Revised Implementing Rules Regulations (IRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act".
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

5. Interested bidders may obtain further information from the Provincial Government of Leyte and inspect the Bidding Documents at the address given below during office hours, from Monday to Friday.
6. A complete set of Bidding Documents may be purchased by interested Bidders beginning **September 15, 2017** from the address below and upon payment of a non-refundable fee for the bidding documents as follows:

8. Bids must be delivered on or before **10:00 AM** on **October 10, 2017** at the PPDO Conference Room, Provincial Capitol, Tacloban City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids shall not be accepted.
9. Bid opening shall immediately follow at **10:30 AM** on **October 10, 2017** at the same venue. Bids will be opened in the presence of the Bidders' representatives who may choose to attend.
10. The Provincial Government of Leyte reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
