2. The Provincial Government of Leyte, through its Bids and Awards Committee, now invites bids for the above-mentioned civil works. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidders should have completed a contract similar to the project to be bid with a value equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary 'pass/fail' criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act".

4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
5. Interested bidders may obtain further information from the Provincial Government of Leyte and inspect the Bidding Documents at the address given below during office hours, from Monday to Friday.
6. A complete set of Bidding Documents may be purchased by interested Bidders beginning **January 30, 2018** from the address below and upon payment of a non-refundable fee for the bidding documents as follows:

8. Bid opening shall immediately follow at **10:30 AM on February 7, 2018** at the same venue. Bids will be opened in the presence of the Bidders' representatives who choose to attend.
9. The Provincial Government of Leyte reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
